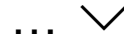

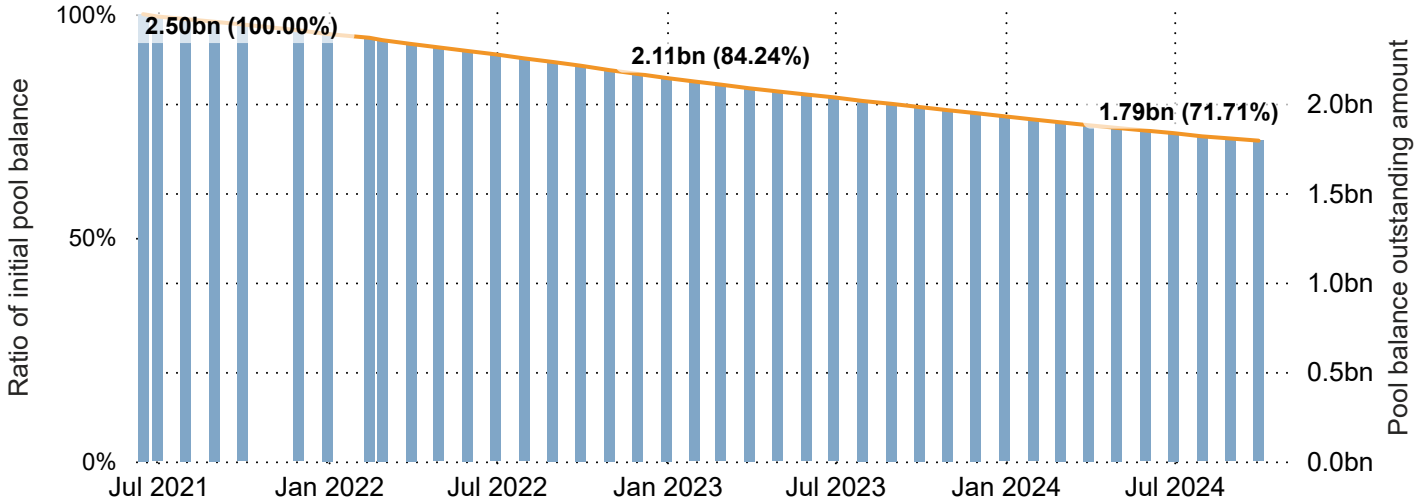

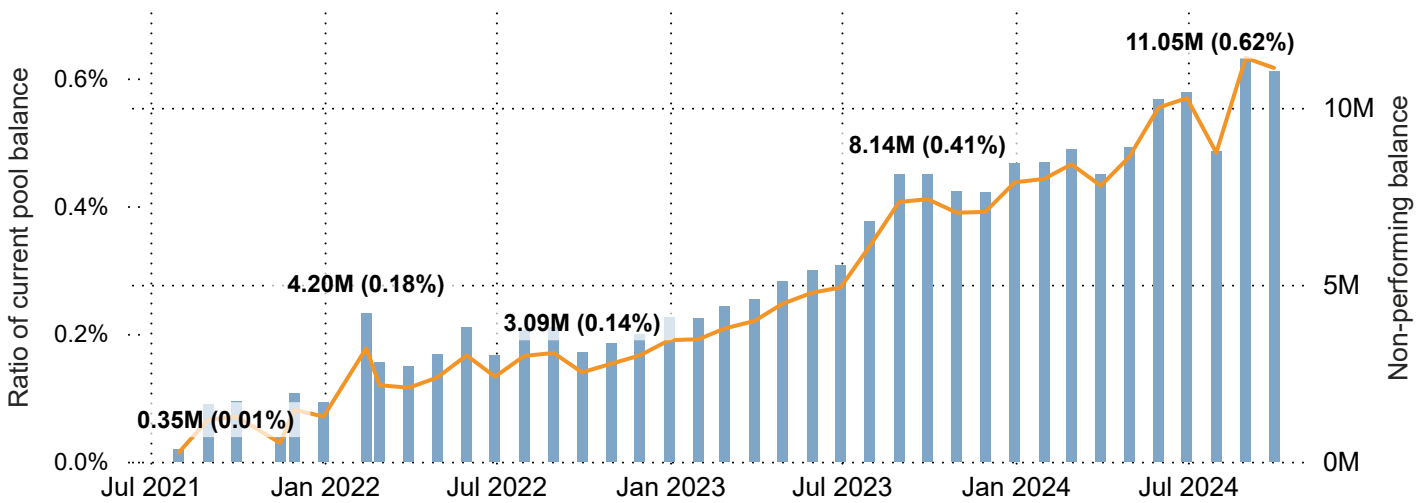
Asset pool balance (currency : EUR)

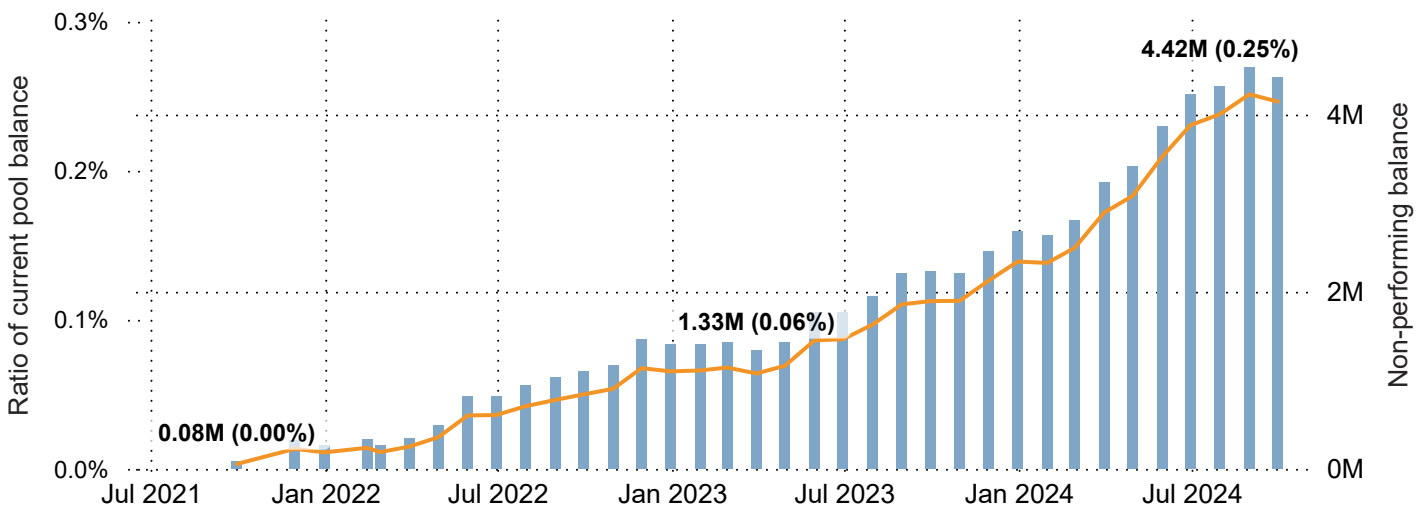
Non-performing balance due for more than 30 days in arrears (currency : EUR)

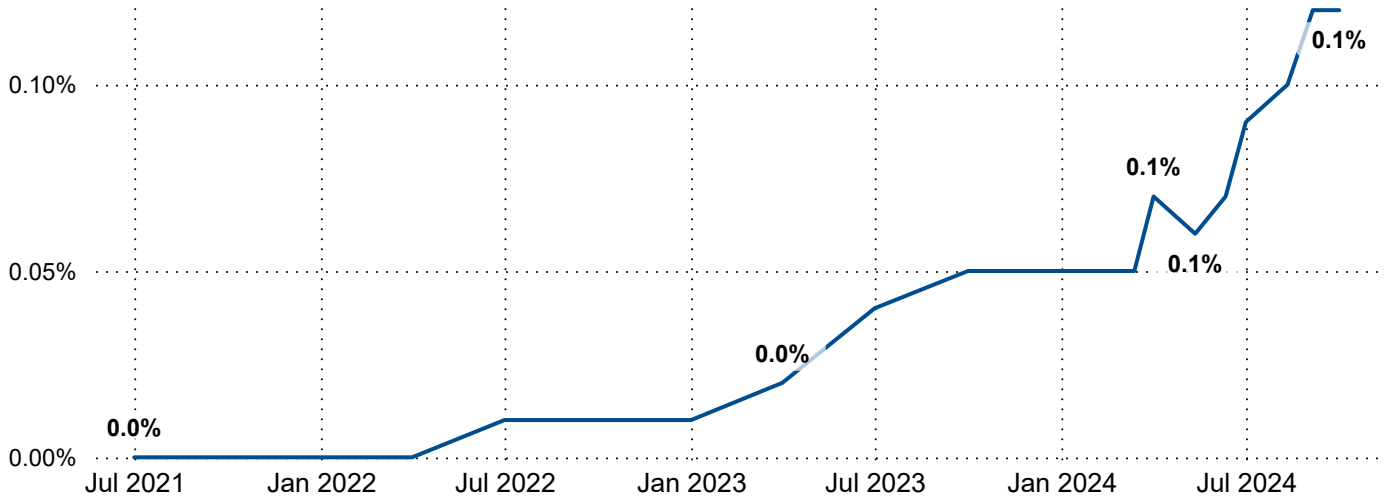

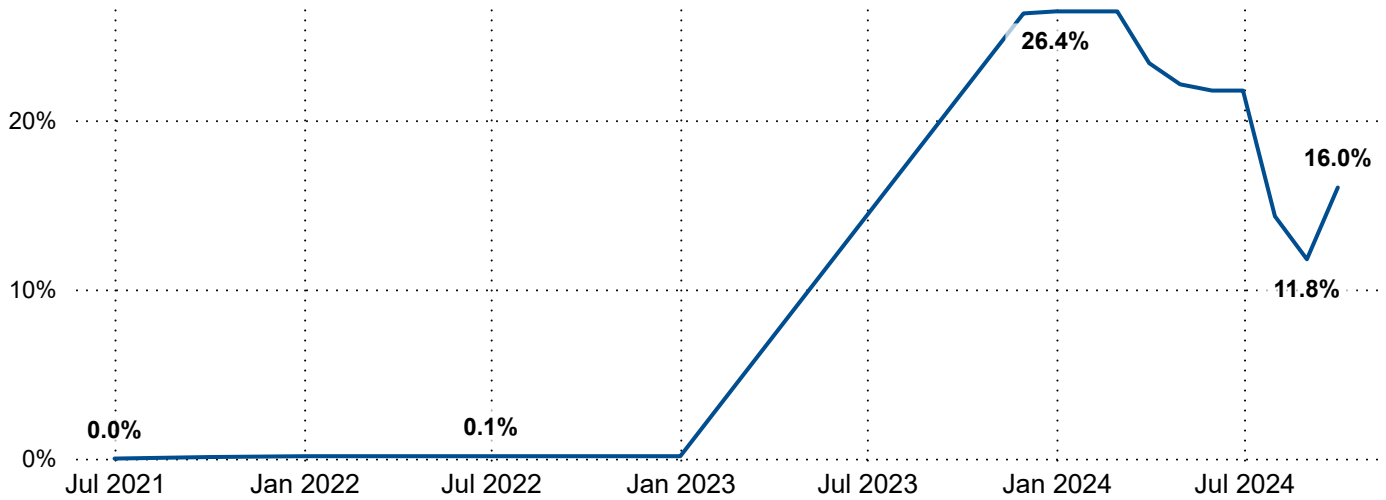
Cumulative default ratio (default : 12M)

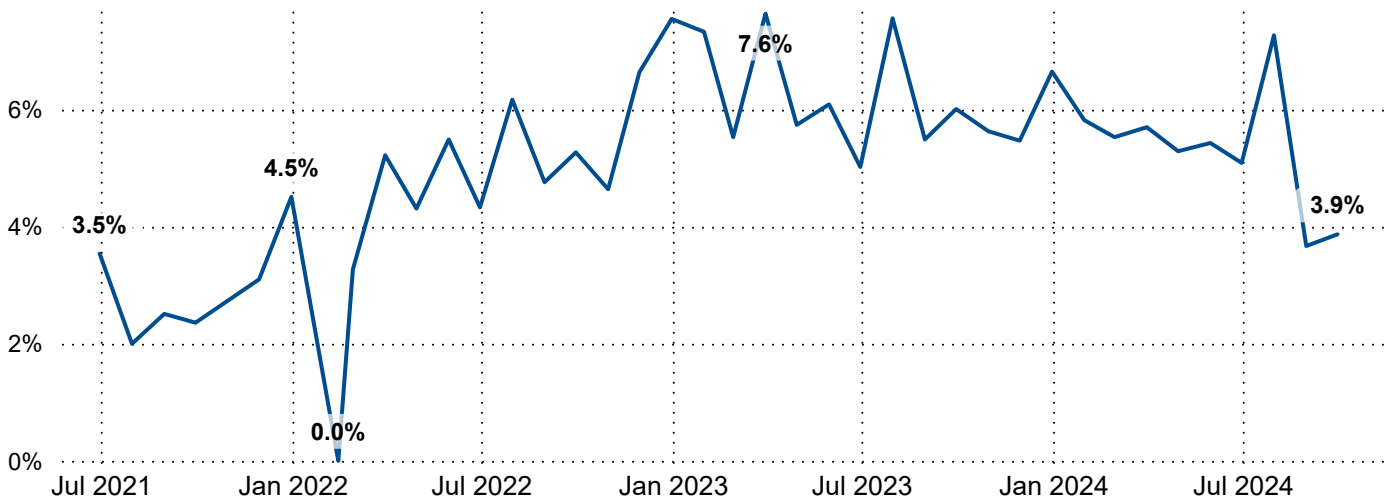
Cumulative recovery ratio (default : 12M)

Annualised constant prepayment rate (CPR)

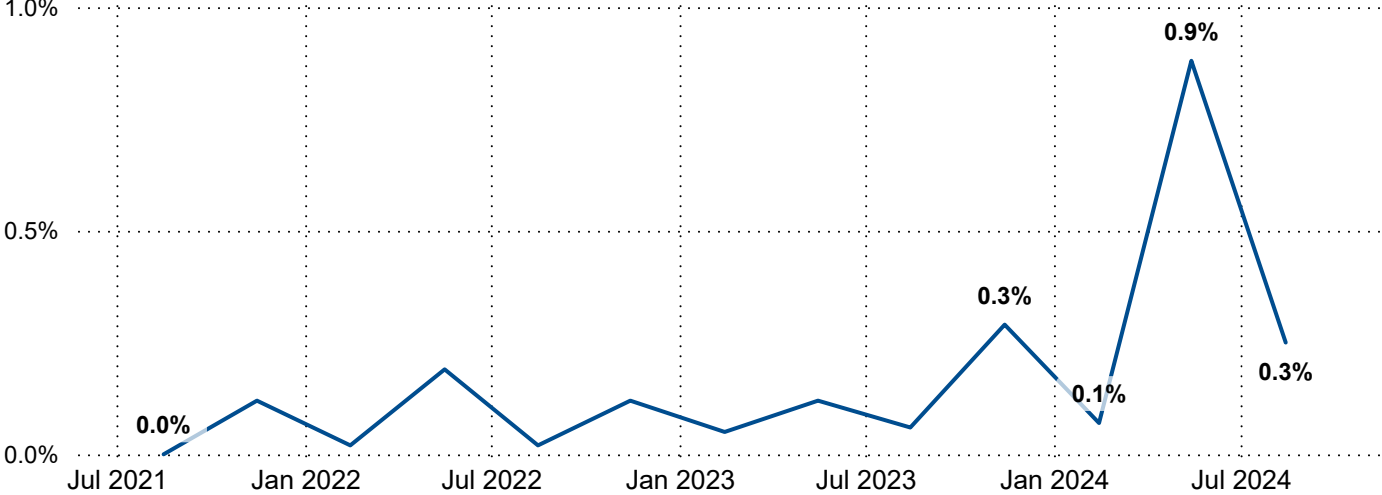

Annualised constant default ratio (CDR)

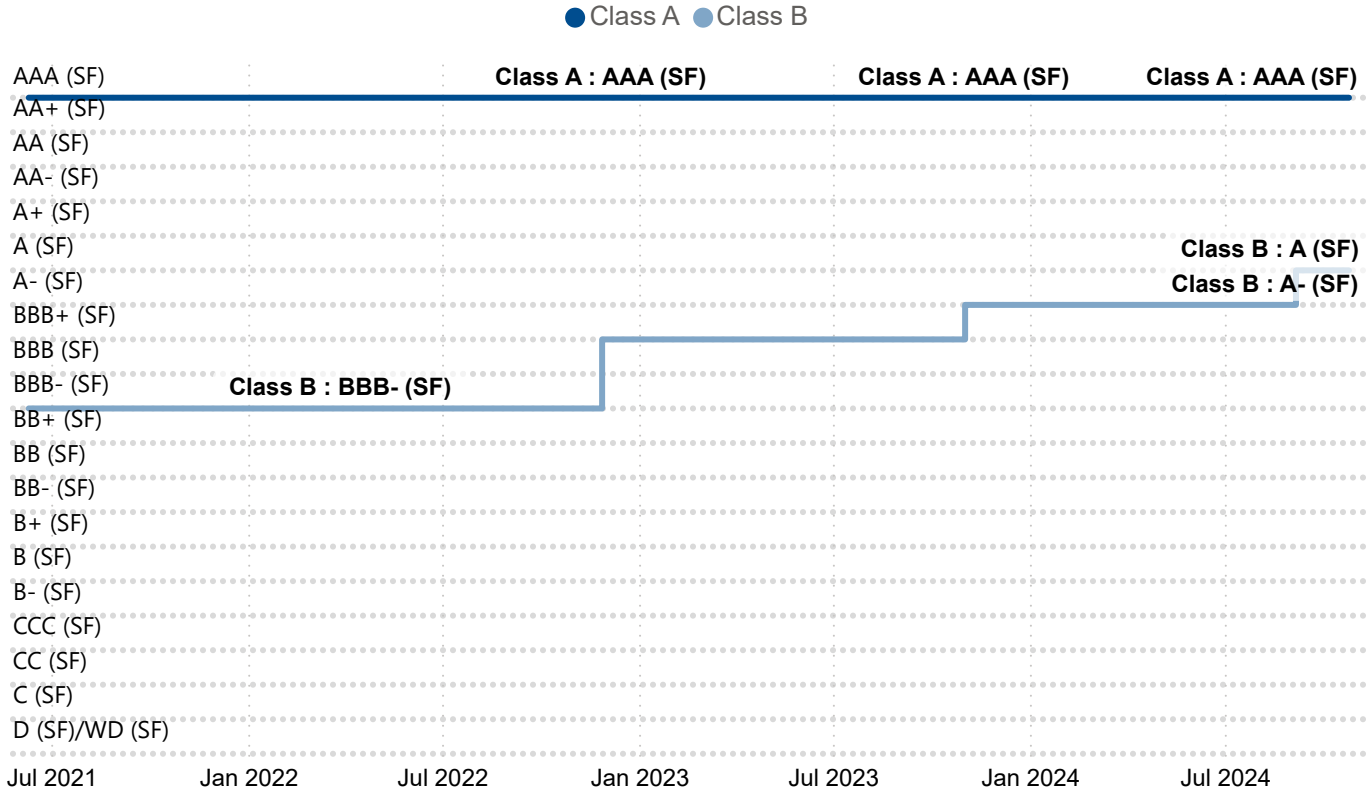

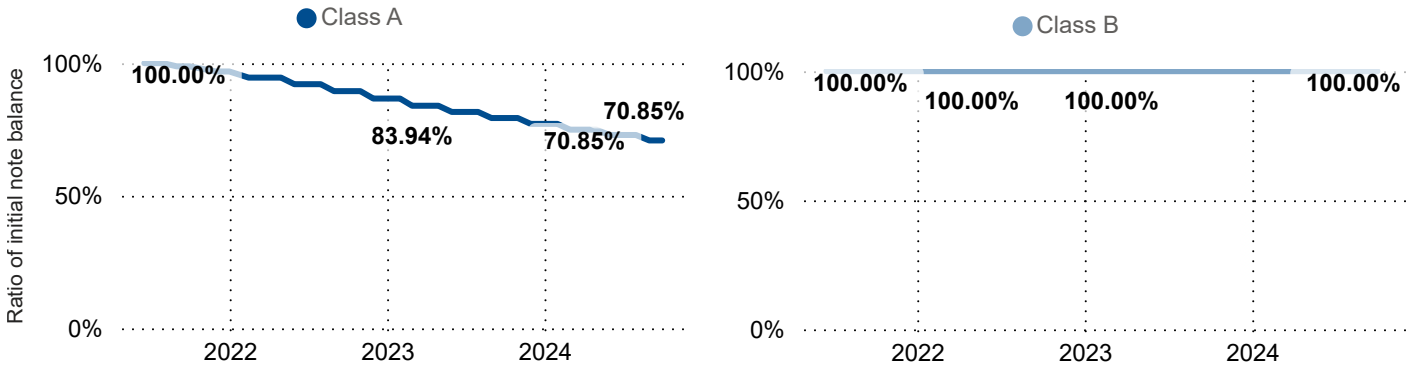

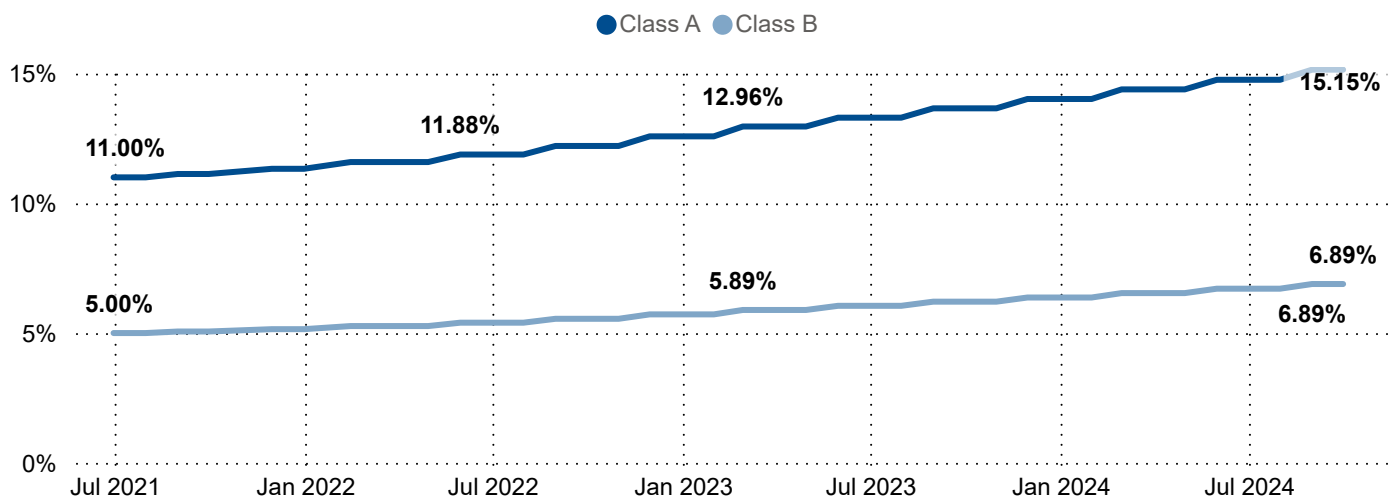

Credit enhancement

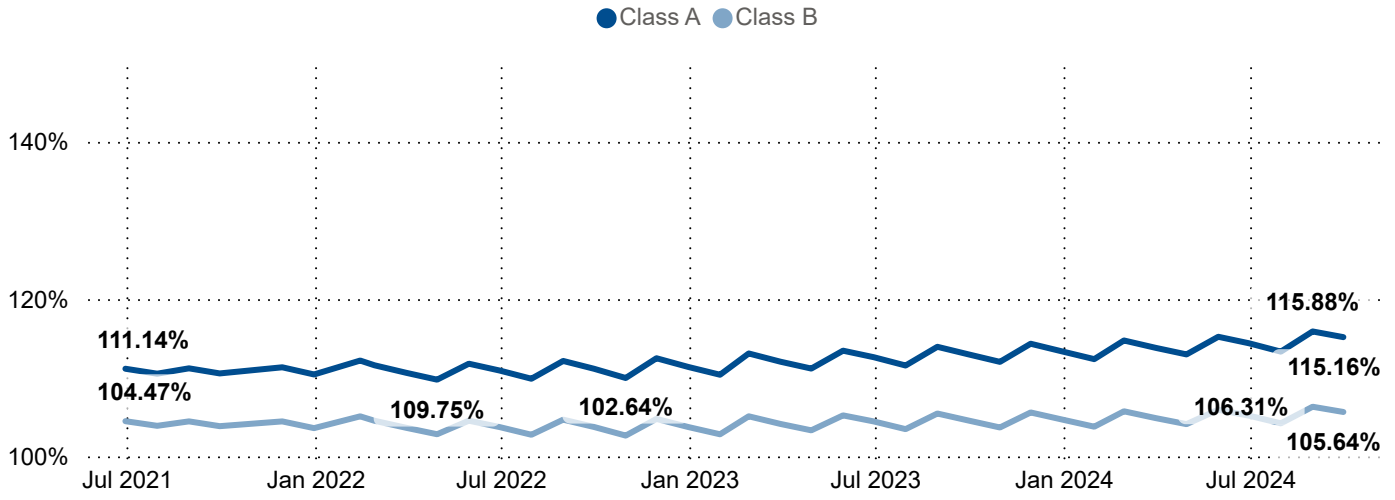
