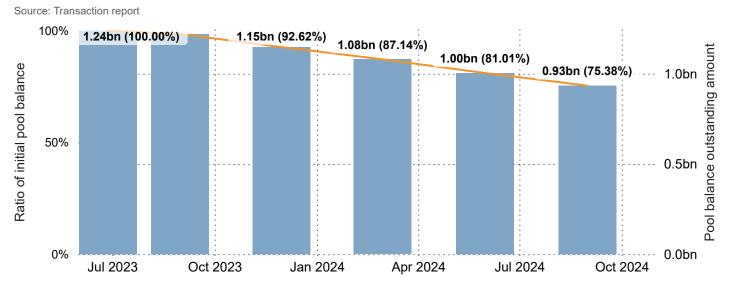

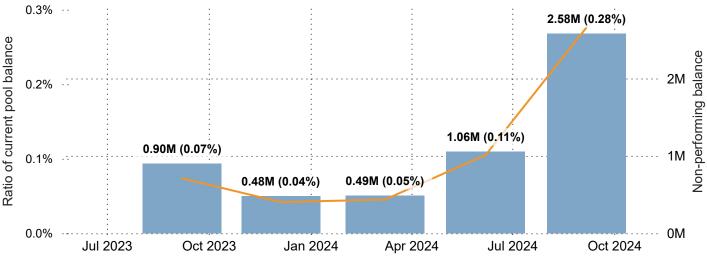

Asset pool balance (currency : EUR)



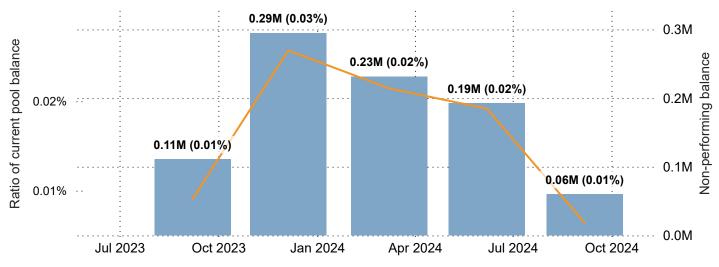
Non-performing balance due for more than 30 days in arrears (currency : EUR)

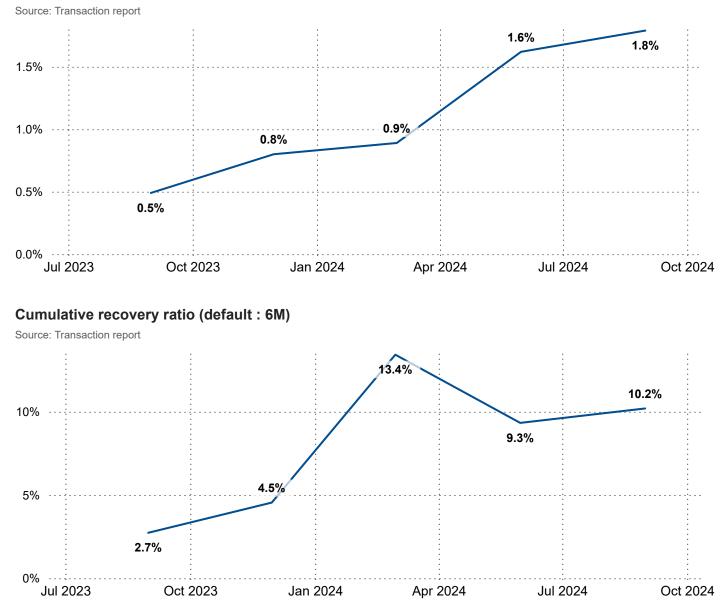

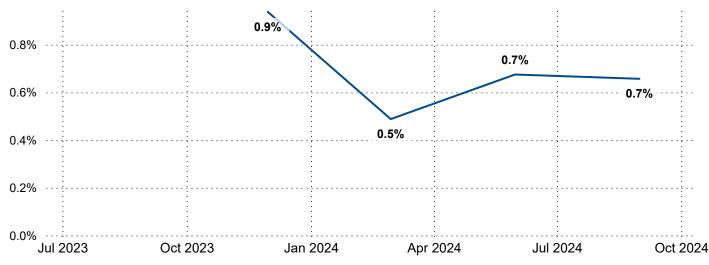

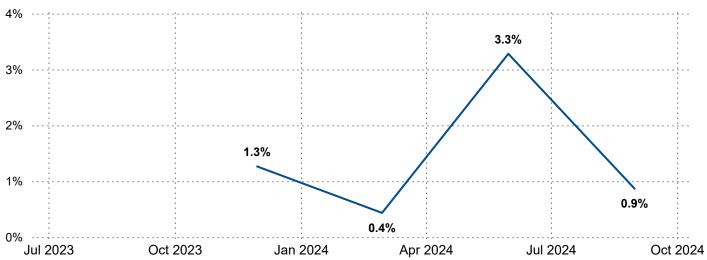

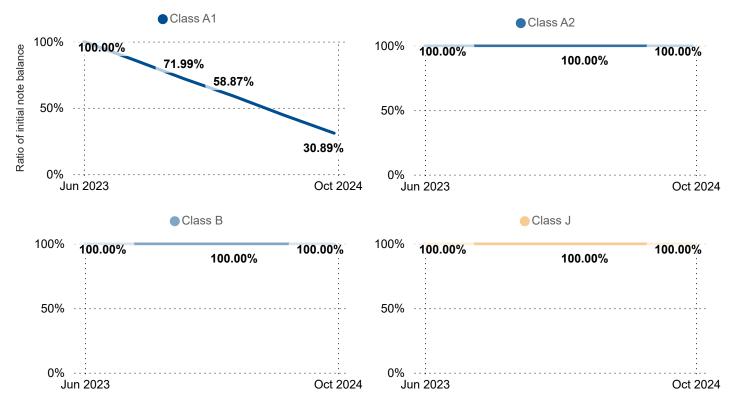

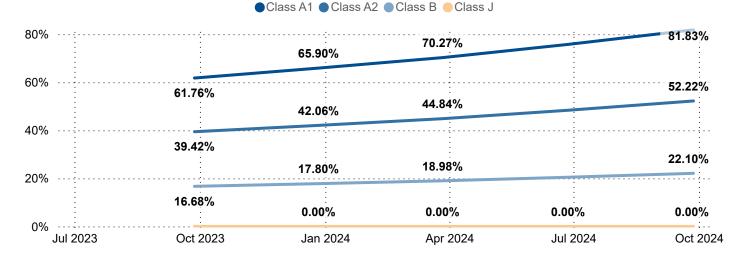
Outstanding notes balance

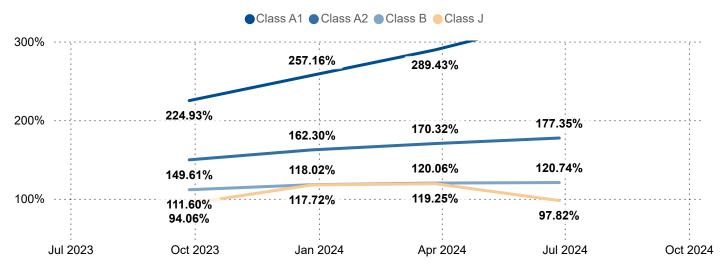

Remarks on the transaction

Field name	Description
